### What is the purpose of this update?

This document tells you how the Global Income Portfolio has performed and what fees were charged. The document will help you to compare the fund with other funds. New Zealand Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The objective of the Global Income Portfolio is to provide exposure to income assets using an active management approach. It is anticipated that the fund will mainly hold cash and cash equivalents and international bonds. It may also invest in Australasian bonds and other permitted assets.

### What are the risks of investing?

Risk indicator for the Global Income Portfolio:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

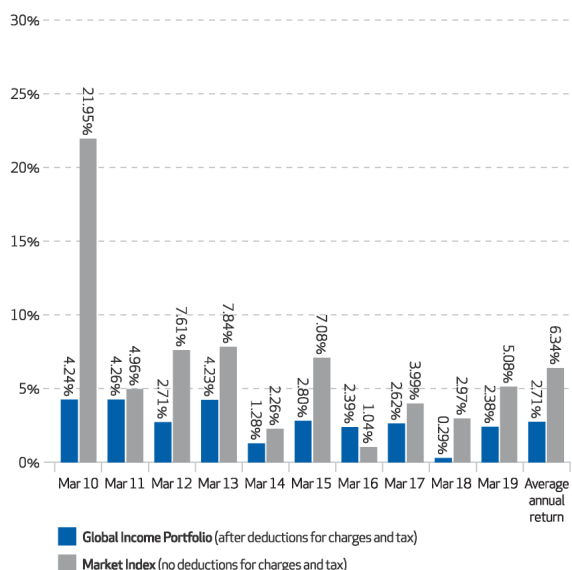

Small differences in fees and charges can have a big impact on your investment over the long term.

## Example of how this applies to an investor

Liam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Liam received a return after fund charges were deducted of \$238 (that's 2.38% of his initial \$10,000). Liam did not pay any other charges. This gives Liam a total return after tax of \$238 for the year.

The top 10 investments make up 96.40% of the fund.<sup>3</sup>

NZ Funds actively manages the foreign currency exposure of the fund. Where the fund holds assets denominated in a foreign currency, NZ Funds has the choice of whether to hedge back to the NZ dollar or retain a foreign currency exposure. The fund may also take active foreign currency positions by holding non-NZD cash and/or foreign currency derivatives. As at 31 March 2019, the fund's foreign currency exposure was 1.27%.

## Notes

For the purposes of this update, the target investment mix has been compiled using the actual investment mix. 3. The top 10 investments have been compiled using a balance sheet approach. This differs from the approach used in compiling the actual and target investment mixes, which include the impact of derivatives.
