What is the purpose of this update?

This document tells you how the Core Income Portfolio has performed and what fees were charged. The document will help you to compare the fund with other funds. New Zealand Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The objective of the Core Income Portfolio is to provide exposure to income assets. The fund is anticipated to hold mainly Australasian bonds.

Total value of the fund \$124,112,088

The date the fund started 23 July 2008

What are the risks of investing?

Risk indicator for the Core Income Portfolio:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

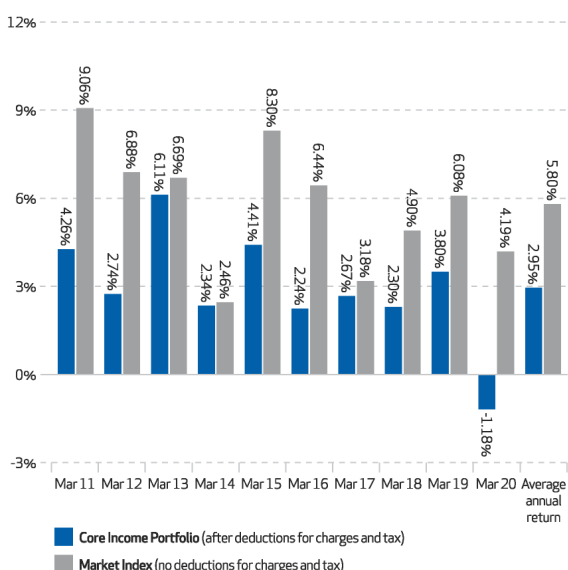

How has the fund performed?

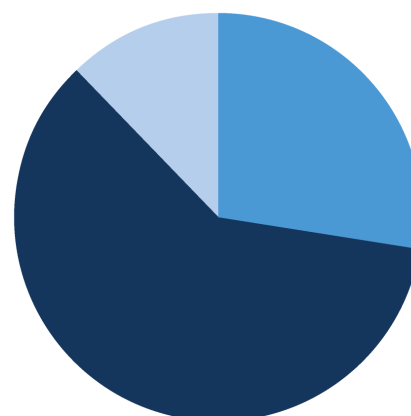
Example of how this applies to an investor

Liam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Liam incurred a loss after fund charges were deducted of -\$118 (that's -1.18% of his initial \$10,000). Liam did not pay any other charges. This gives Liam a total loss after tax of -\$118 for the year.

The top 10 investments make up 55.92% of the fund.³

NZ Funds actively manages the foreign currency exposure of the fund. Where the fund holds assets denominated in a foreign currency, NZ Funds has the choice of whether to hedge back to the NZ dollar or retain a foreign currency exposure. The fund may also take active foreign currency positions by holding non-NZD cash and/or foreign currency derivatives. As at 31 March 2020, the fund's foreign currency exposure was 3.70%.
