What is the purpose of this update?

This document tells you how the Core Cash Portfolio has performed and what fees were charged. The document will help you to compare the fund with other funds. New Zealand Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The objective of the Core Cash Portfolio is to provide a source of capital. The fund is anticipated to hold mainly cash and cash equivalents.

Total value of the fund \$31,122,364

The date the fund started 28 February 2008

What are the risks of investing?

Risk indicator for the Core Cash Portfolio:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



How has the fund performed?


Example of how this applies to an investor

Liam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Liam received a return after fund charges were deducted of \$13 (that's 0.13% of his initial \$10,000). Liam did not pay any other charges. This gives Liam a total return after tax of \$13 for the year.
