What is the purpose of this update?

Description of this fund

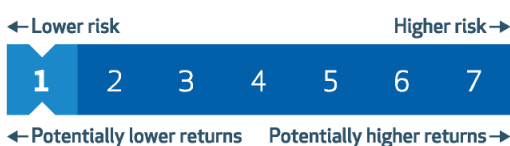
The objective of the Core Cash Portfolio is to provide a source of capital. The fund is anticipated to hold mainly cash and cash equivalents.

Total value of the fund \$28,759,114

What are the risks of investing?

Risk indicator for the Core Cash Portfolio:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

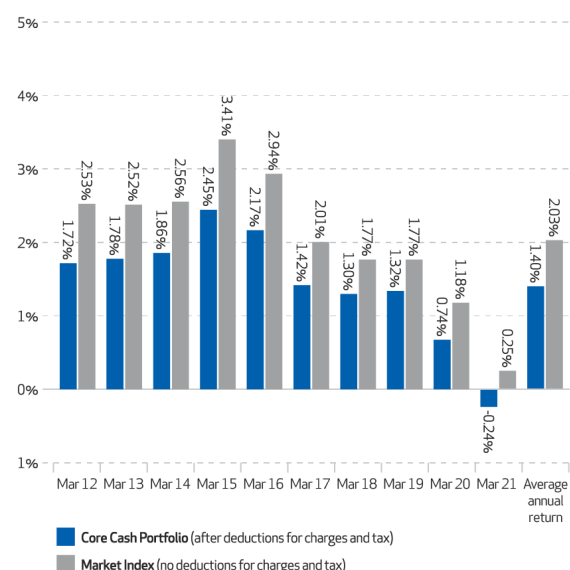

How has the fund performed?

Investors in the Core Cash Portfolio are charged fund charges. In the year to 31 March 2021 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.

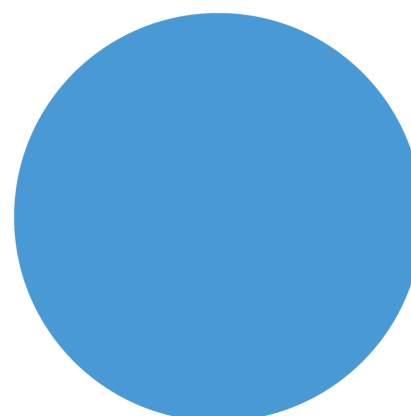
Example of how this applies to an investor

Liam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Liam incurred a loss after fund charges were deducted of -\$21 (that's -0.21% of his initial \$10,000). Liam did not pay any other charges. This gives Liam a total loss after tax of -\$21 for the year.

Notes
