### What is the purpose of this update?



#### What fees are investors charged?

Investors in the Core Cash Portfolio are charged fund charges. In the year to  $31\,March\,2021$  these were:

Small differences in fees and charges can have a big impact on your investment over the long term.


# Example of how this applies to an investor

Liam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Liam incurred a loss after fund charges were deducted of -\$5 (that's -0.05% of his initial \$10,000). Liam did not pay any other charges. This gives Liam a total loss after tax of -\$5 for the year.
