NZ Funds KiwiSaver Scheme LifeCycle - age 75

This fund update was first made publicly available on 15 February 2021

What is the purpose of this update?

This document tells you how the LifeCycle - age 75 investment option has performed and what fees were charged. The document will help you to compare the investment option with other investment options. New Zealand Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this investment option

The objective of LifeCycle is to allocate your investment across the three funds (Strategies) in the Scheme based on your age to ensure your investment is allocated in a manner consistent with your investment timeframe. At age 75, your investment will be allocated as follows: 35% to the Income Strategy; 34% to the Inflation Strategy; and 31% to the Growth Strategy.

What are the risks of investing?

Risk indicator for the LifeCycle - age 75:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the investment option's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

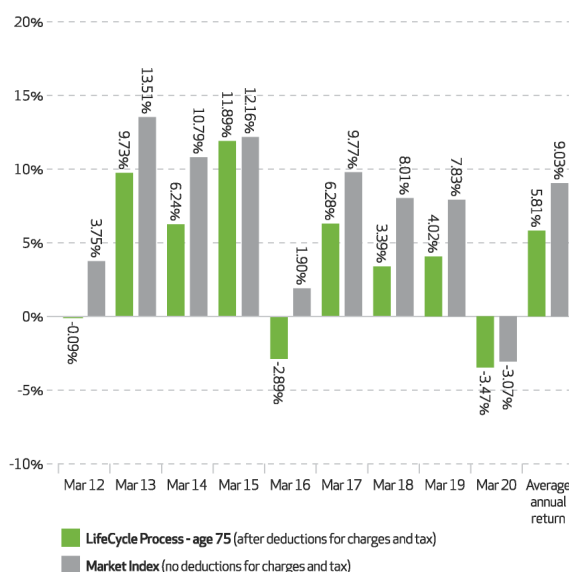

How has the investment option performed?

Annual return graph²



This shows the return after fund charges and tax for each year ending 31 March since the investment option started. The last bar shows the average annual return since the investment option started, up to 31 December 2020.

What fees are investors charged?

Investors in the LifeCycle - age 75 are charged fund charges. In the year to 31 March 2020 these were:

*Note: Included within 'Other management and administration charges' are performance-based fees charged by external managers of underlying funds that the fund invested into which totalled 0.11%. Performance-based fees are subject to market movements and manager performance and the amount of these fees for any given period may materially differ from those disclosed for the year to 31 March 2020. For the 12 months to 31 December 2020, external manager performance fees were 0.53% and NZ Funds' performance fee was 0.17%. As a result, total fund charges for that period totalled 2.18%.

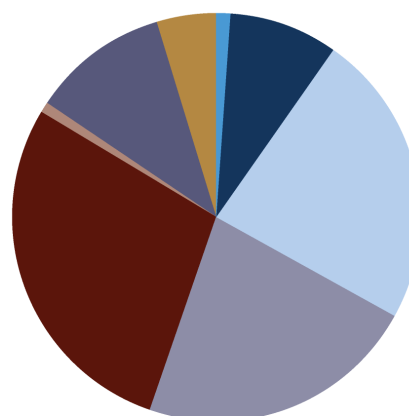
Example of how this applies to an investor

Liam had \$10,000 in the investment option at the start of the year and did not make any further contributions. At the end of the year, Liam received a return after fund charges were deducted of \$1,419 (that's 14.19% of his initial \$10,000). Liam also paid \$36 in other charges. This gives Liam a total return after tax of \$1,383 for the year.

The top 10 investments make up 43.34% of the investment option.⁶

NZ Funds actively manages the foreign currency exposure of the investment option. Where the investment option holds assets denominated in a foreign currency, NZ Funds has the choice of whether to hedge back to the NZ dollar or retain a foreign currency exposure. The investment option may also take active foreign currency positions by holding non-NZD cash and/or foreign currency derivatives. As at 31 December 2020, the investment option's foreign currency exposure was 18.25%.

Notes

1. The total value and number of investors in the NZ Funds KiwiSaver Scheme Lifecycle overall is \$309,348,132 and 9,487 respectively.
2. The bar graph shows investment option returns after the deduction of fees and tax; however, the market index returns are shown before any fees or tax are deducted.
3. Other management and administration charges comprise:
 - (a) operating costs directly incurred by the investment option; and
 - (b) annual management fees, performance-based fees and operating costs incurred by underlying funds the investment option invests into.

Estimates were used when deriving annual management fees, performance-based fees and operating costs incurred by the following underlying funds the fund invested into.

Suvretta Offshore Fund	The fee and operating cost amount obtained from the manager of the fund was for the year to 31 December 2019. Performance fee amounts are estimated using the same criteria used by the administrator of the fund.
Emerson Point Capital Partners LP	The fee and operating cost amount obtained from the manager of the fund was for the year to 31 December 2019. Performance fee amounts are estimated using the same criteria used by the administrator of the fund.

4. For investors aged 18 or over, the Administration Manager of the NZ Funds KiwiSaver Scheme charges an administration fee of \$3 a month.
5. Targets indicate what are expected to apply over the course of an economic cycle and should be considered as general guidance only. NZ Funds is an active manager and may use investment strategies that differ materially from the targets.
6. The top 10 investments have been compiled using a balance sheet approach. This differs from the approach used in compiling the actual and target investment mixes, which include the impact of derivatives.
