

# Investment update

## NZ Funds KiwiSaver Scheme LifeCycle - age 75

This fund update was first made publicly available on 1 November 2021

### What is the purpose of this update?

This document tells you how the LifeCycle - age 75 investment option has performed and what fees were charged. The document will help you to compare the investment option with other investment options. New Zealand Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this investment option

The objective of LifeCycle is to allocate your investment across the three funds (Strategies) in the Scheme based on your age to ensure your investment is allocated in a manner consistent with your investment timeframe. At age 75, your investment will be allocated as follows: 35% to the Income Strategy; 34% to the Inflation Strategy; and 31% to the Growth Strategy.

### What are the risks of investing?

Risk indicator for the LifeCycle - age 75:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the investment option's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

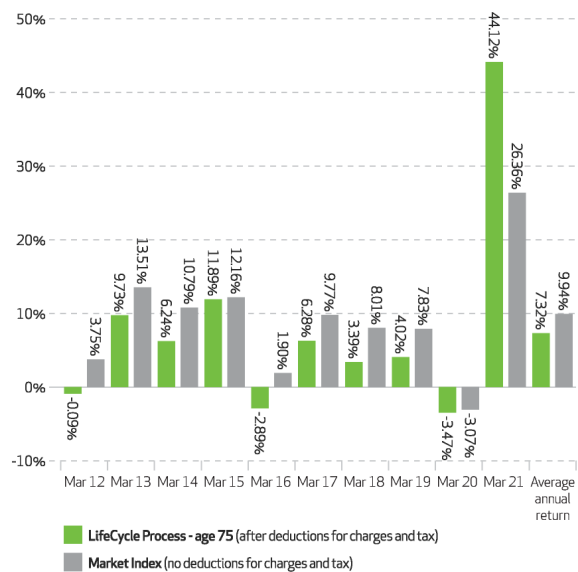

### How has the investment option performed?

### Annual return graph<sup>2</sup>



This shows the return after fund charges and tax for each year ending 31 March since the investment option started. The last bar shows the average annual return since the investment option started, up to 30 September 2021.

## What fees are investors charged?

\*Note: Included within 'Other management and administration charges' are performance-based fees charged by external managers of underlying funds that the fund invested into which totalled 0.68%. Performance-based fees are subject to market movements and manager performance and the amount of these fees for any given period may materially differ from those disclosed for the year to 31 March 2021. For the 12 months to 30 September 2021, external manager performance fees were 0.38% and NZ Funds' performance fee was 0.22%. As a result, total fund charges for that period totalled 2.27%.

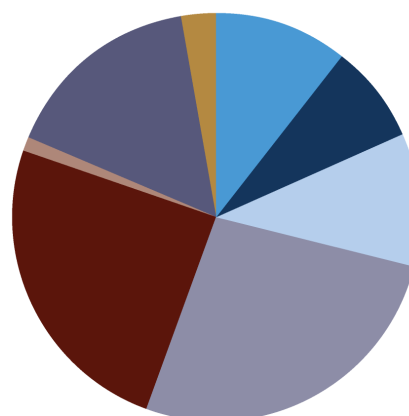
## Example of how this applies to an investor

Liam had \$10,000 in the investment option at the start of the year and did not make any further contributions. At the end of the year, Liam received a return after fund charges were deducted of \$2,313 (that's 23.13% of his initial \$10,000). Liam also paid \$36 in other charges. This gives Liam a total return after tax of \$2,277 for the year.

The top 10 investments make up 44.71% of the investment option.<sup>8</sup>

NZ Funds actively manages the foreign currency exposure of the investment option. Where the investment option holds assets denominated in a foreign currency, NZ Funds has the choice of whether to hedge back to the NZ dollar or retain a foreign currency exposure. The investment option may also take active foreign currency positions by holding non-NZD cash and/or foreign currency derivatives. As at 30 September 2021, the investment option's foreign currency exposure was 18.68%.

## Notes

1. The total value and number of investors in the NZ Funds KiwiSaver Scheme Lifecycle overall is \$584,464,548 and 13,999 respectively.
2. The bar graph shows investment option returns after the deduction of fees and tax; however, the market index returns are shown before any fees or tax are deducted.
3. Other management and administration charges comprise:
  - (a) operating costs directly incurred by the investment option; and
  - (b) annual management fees, performance-based fees and operating costs incurred by underlying funds the investment option invests into.
 Estimates were used when deriving annual management fees, performance-based fees and operating costs incurred by the following underlying funds the fund invested into.

Suvretta Offshore Fund	The fee and operating cost amount obtained from the manager of the fund was for the year to 31 December 2020. Performance fee amounts are estimated using the same criteria used by the administrator of the fund.
Emerson Point Capital Partners LP	The fee and operating cost amount obtained from the manager of the fund was for the year to 31 December 2020 and an annualized amount for the period from January 2021 to February 2021. Performance fee amounts are estimated using the same criteria used by the administrator of the fund.
Galaxy Institutional Bitcoin Fund	The fee and operating cost amount obtained from the manager of the fund was for the year to 31 December 2020.
Galaxy Institutional Ethereum Fund	The fee and operating cost amount obtained from the manager of the fund was for the year to 31 December 2020.

4. Total performance based fees are paid with respect to certain related underlying funds managed by NZ Funds and are payable where performance of the underlying funds exceeds the hurdle rate. Details of the underlying funds to which a performance fee applies can be found in the PDS, along with details of the hurdle rate and the percentage amount of the performance fee applying to each underlying fund.
5. For investors aged 18 or over, the Administration Manager of the NZ Funds KiwiSaver Scheme charges an administration fee of \$3 per month.
6. NZ Funds uses derivatives as part of its active management approach. The use of derivatives can result in the total economic exposure of the fund exceeding 100% which means the fund is leveraged. Where economic exposure exceeds 100%, the actual investment mix pie graph has been scaled to 100%.

Without scaling, the total economic exposure of the fund, as shown in the actual investment mix would be 139.81%, made up as follows: Cash and cash equivalents 14.91%; New Zealand fixed interest 11.00%; International fixed interest 14.49%; Australasian equities 37.55%; International equities 34.49%; Listed property 1.44%; Commodities 22.34% and Other 3.58%.
