On 1 December 2020, change to the fees payable by the Strategies were implemented, including the introduction of a performance-based fee in the:

- · Private Global Inflation Trust: and
- · Private Global Macro Trust,

being related underlying funds that the Inflation and Growth Strategies invest in.

Statement Of Investment Policy and Objectives (SIPO)

On 21 October 2020, the SIPO was updated to:

- · remove economic exposure limits for the Strategies;
- update target asset allocations for the Strategies;
- reflect additional exclusions under NZ Funds' Responsible Investment Policy; and
- update the Glossary by adding cryptocurrencies as an example of 'Alternative securities'.

Related party transactions

The scale of the related party transactions for the Schemes changed during the year due to the introduction of performance-based fees in the:

- Private Global Inflation Trust: and
- · Private Global Macro Trust,
